TRANSITION RESOURCE ACTION CENTER (TRAC) PROVIDES A "ONE STOP" ASSESSMENT/INTAKE AND REFERRAL FACILITY FOR TRANSITIONAL LIVING SERVICES FOR YOUTH EXITING FOSTER AND JUVENILE CARE IN NORTH TEXAS. TRAC BRINGS TOGETHER COMMUNITY RESOURCES AND INTENSIVE CASE MANAGEMENT SERVICE. IT IS THE ONLY SUCH PROGRAM IN NORTH TEXAS THAT EXISTS TO COMPREHENSIVELY ADDRESS THE NEEDS OF THIS POPULATION. TRAC IS THE REGIONAL SAFETY NET FOR FORMER FOSTER YOUTH ONCE THEY ARE ON THEIR OWN. ANNUALLY, TRAC HELPS OVER 900 OF THE MOST CHALLENGED AT-RISK TEENS MAKE A LIFE PLAN AND ACQUIRE SKILLS THEY NEED TO SURVIVE ON THEIR OWN AFTER THEY TURN AGE 18.

IN 2015, THE PROGRAMS DELIVERED OVER 1,000,000 MEALS TO OVER 20,000 CHILDREN AT 200 LOCATIONS IN DALLAS, AUSTIN & WACO. DURING 2015, THE FOOD PANTRY DISTRIBUTED OVER 1,000,000 POUNDS OF FOOD TO ALMOST 18,000 UNDUPLICATED INDIVIDUALS. IN ADDITION, THE FOOD PANTRY
