HEALTH PROGRAMS:COMMUNITY HEALTH SERVICES (CHS) PARTNERS WITH FAMILIES AND INDIVIDUALS TO CREATE CLEAR MOVEMENT TOWARD BETTER HEALTH AND QUALITY OF LIFE. CHS OPERATES A FAMILY MEDICINE CLINIC AND PROVIDES HIGH-QUALITY PRIMARY, PREVENTIVE ADULT AND PEDIATRIC, CHRONIC AND NON-EMERGENCY ACUTE CARE TO OVER 1,600 UNINSURED NEIGHBORS, AMOUNTING TO OVER 4,800 TOTAL HEALTH RELATED ENCOUNTERS IN 2019. ADDITIONALLY, CHS WORKS HARD TO SUPPORT PATIENTS IN THE SELF-MANAGEMENT OF CHRONIC DISEASES, WITH A SPECIAL EMPHASIS ON DIABETES. CHS LEVERAGES SIGNIFICANT COMMITMENTS OF ADDITIONAL RESOURCES THROUGH COLLABORATIVE PARTNERSHIPS WITH BAYLOR HEALTH CARE SYSTEM, INC. AND ITS EMPLOYED HEALTH TEXAS PHYSICIAN NETWORK. AS AN EXTENSION OF THE CHS CLINIC, SATELLITE CLINICS ARE OPERATED AT CITY SQUARE HOUSING SITES. CITY SQUARE'S COMMUNITY HEALTH NURSE HELPS NAVIGATE UNINSURED INDIVIDUALS LIVING IN CITY SQUARE HOUSING PROGRAMS TO THE SATELLITE CLINICS AS WELL AS PROVIDING HEALTHY LIFESTYLE CLASSES THAT EMPHASIZE NUTRITION, PHYSICAL ACTIVITY AND WELLNESS COMPONENTS. IN 2019, CITY SQUARE'S COMMUNITY HEALTH NURSE AND COMMUNITY HEALTH WORKER PERFORMED OVER 130 NAVIGATION SERVICES FOR CITY SQUARE NEIGHBORS NEEDING HEALTH AND WELLNESS SUPPORT SERVICES. COMMUNITY HEALTH TRANSPORTATION PROGRAM (CHTP) WORKS TO ADDRESS SOCIAL DETERMINANTS OF HEALTH BY REMOVING TRANSPORTATION BARRIERS THAT PATIENTS OFTEN FACE WHEN TRYING TO ACCESS HEALTH CARE. THE CHTP TEAM DRIVES UNINSURED PATIENTS TO THEIR MEDICAL APPOINTMENTS ACROSS DALLAS COUNTY. IN 2019, THE CHTP SUCCESSFULLY COMPLETED OVER 1,400 TRANSPORTATION REQUESTS FOR MEDICAL APPOINTMENTS FOR NEARLY 550 INDIVIDUALS. AT THE END OF 2019 THE CHTP PROGRAM SUNSET TO A NEW MODEL NO LONGER OPERATED BY CITY SQUARE.
